## **ARTICLES OF ORGANIZATION**

**for**

### **OLD FLORIDA YACHT CLUB, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ***Article I - NAME***

The name of the limited liability company shall be Old Florida Yacht Club, LLC ("Company").

#### ***Article II - STREET ADDRESS***

The street address of the principal office of the Company shall be: 1900 East Adams Drive, Maitland, Florida 32751.

#### ***Article III - MAILING ADDRESS***

The mailing address of the Company shall be: 1900 East Adams Drive, Maitland, Florida 32751.

#### ***Article IV - DURATION***

The Company is to exist as provided in the Operating Agreement of the Company.

#### ***Article V - PURPOSES AND POWERS***

The general purpose for which the Company is organized is to transact all lawful business as specified in the Operating Agreement of the Company. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

#### ***Article VI - MANAGEMENT***

The Company shall be managed by one (1) or more managers and is, therefore, a manager-managed company.

#### ***Article VII - INITIAL REGISTERED OFFICE AND AGENT***

The street address of the initial registered office of the Company is: 1515 International Parkway, Suite 2001, Lake Mary, Florida 32746, and the name of the initial registered agent for service of process at that address is Robert J. Hutchins.

#### ***Article VIII - ADMISSION OF NEW MEMBERS***

No additional members shall be admitted to the Company except pursuant to the provisions of the Operating Agreement of the Company. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member except as provided in the Operating Agreement of the Company.

#### ***Article IX - INDEMNIFICATION***

The Company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.




