# ARTICLES OF ORGANIZATION for OLD FLORIDA YACHT CLUB, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### Article I - NAME

The name of the limited liability company shall be Old Florida Yacht Club, LLC ("Company").

#### Article II - STREET ADDRESS

The street address of the principal office of the Company shall be: 1900 East Adams Drive, Maitland, Florida 32751.

#### Article III - MAILING ADDRESS

#### Article IV - DURATION

The Company is to exist as provided in the Operating Agreement of the Company.

#### Article V - PURPOSES AND POWERS
