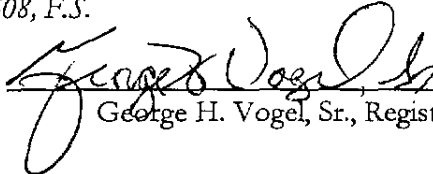

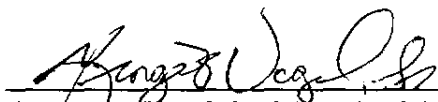

Admission of Additional Members**

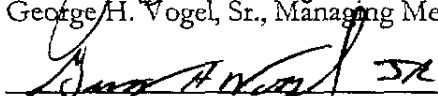
The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be only upon unanimous consent of the then existing member, their successors or assigns.
