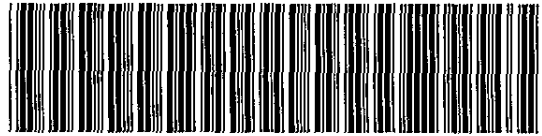

Pursuant to the provisions of Section 608.411 of the *Florida Statutes*, K & K Investments, LLC, a limited liability company organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Organization:

SECTION II - DATE OF FILING OF ARTICLES OF ORGANIZATION


The Articles of Organization were filed on November 22, 2004, and became effective as of the date of filing.
