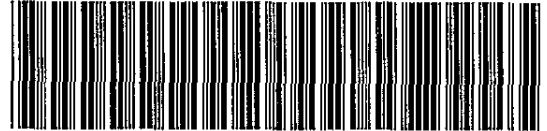

The undersigned adopts the following Articles of Organization for the purpose of becoming a Limited liability Company, under the Florida Limited Liability Company Act.




