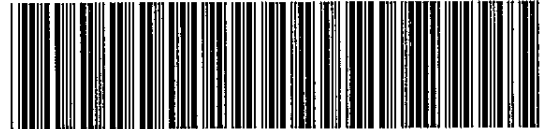

ARTICLE III




