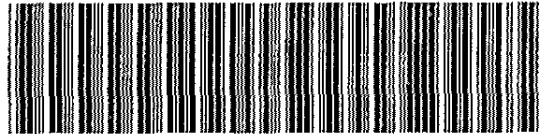


New members shall only be admitted upon the unanimous written consent of then existing members.
