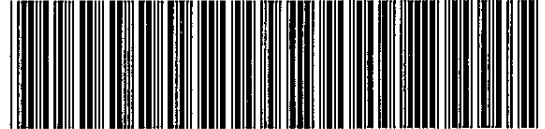



B B & D CUSTOM HOMES, L.L.C.



IN WITNESS WHEREOF, the undersigned, being all of the Members of this limited liability company, have executed these Articles of Amendment on this 20th day of March, 2005.



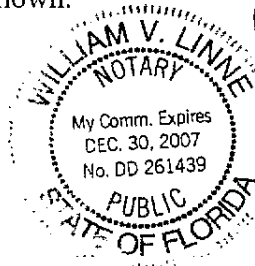




