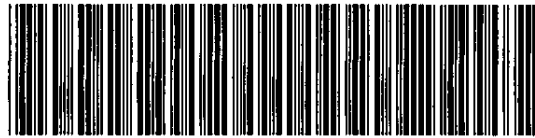



ARTICLES OF DISSOLUTION  
of  
Southern Financial Progress, LLC

Pursuant to Fla. Stat. §608.441(4); Fla. Stat. §§608.445, 446, the Personal Representative of the Estate of Donald A. Haas herewith files the Articles of Dissolution of Southern Financial Progress, LLC and states as follows:

1. The name of the limited liability company is Southern Financial Progress, LLC.
2. The effective date of dissolution is November 13, 2006.
3. The occurrence giving rise to the dissolution is the death of the sole member of the limited liability company, Donald A. Haas on August 13, 2006. Pursuant to Fla. Stat. §608.441(d), the limited liability company is dissolved unless the personal representative agrees in writing to its continuing existence. The personal representative has declined to do so in order to consolidate the estate for expeditious administration.
4. All debts, obligations, and liabilities of the limited liability company have been paid or discharged and there are no further existing debts, obligations, and liabilities.
5. The remaining property and assets have been or are in the process of being distributed to the probate estate for administration in accordance with the sole member's rights and interests.
6. There are no suits pending against the limited liability company and none are contemplated.
