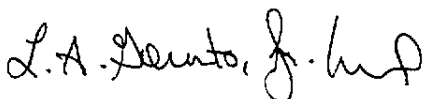

Pursuant to the provisions of Florida Statutes §608.411, Diversified Investments of Volusia County, LLC adopts the following articles of amendment and restatement to its articles of organization:

FIRST: Amendments and restatements adopted:

ARTICLE 1
NAME
