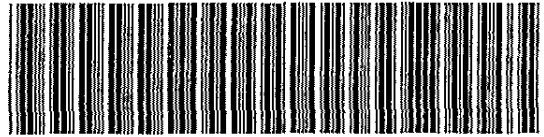

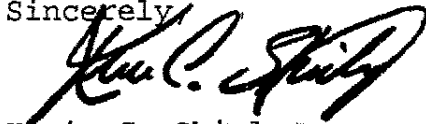

**ARTICLE VIII VOTING AUTHORITY**

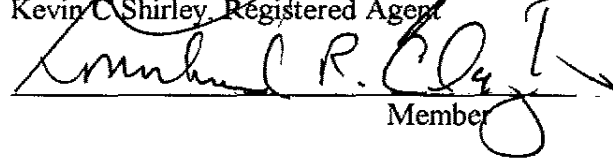
