AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BP PROPERTIES, LLC

Pursuant to the provisions of Chapter 605.0202, Florida Statutes, the following constitutes the amended and restated Articles of Organization of BP Properties, LLC.

SECTION I - NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company is BP Properties, LLC.

SECTION II - DATE OF FILING OF ARTICLES OF ORGANIZATION

The Articles of Organization were filed on November 29, 2004.

SECTION III - AMENDMENT TO AND RESTATEMENT OF THE ARTICLES OF ORGANIZATION

The following constitutes the amendment and restatement of the Articles of Organization of BP Properties, LLC:
