ARTICLES OF ORGANIZATION OF GLOBAL FINANCIAL, LLC

The undersigned member(s)/manager(s), for the purpose of forming a Limited Liability Company: STATE under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of Limited Liability Companies adopt the following articles of organization:

ARTICLE I. NAME

The name of the limited liability company shall be: GLOBAL FINANCIAL, LLC
