CONTINUATION OF BUSINESS

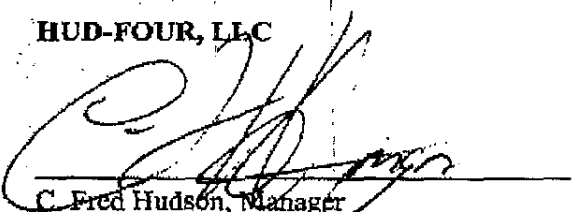
