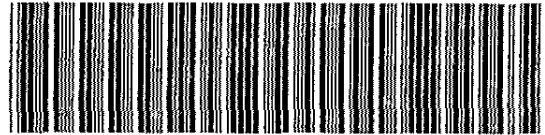

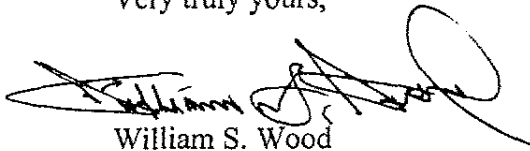

**ARTICLE III. PURPOSE**

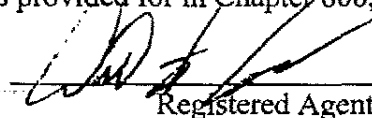
