The undersigned, being authorized to execute and file these Amended Articles, in order to form a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit declares that the following Amended Articles shall serve as the Charter and authority for the conduct of business of the limited liability company under the Limited Liability Company Act, hereby make, acknowledge and file the following Amended Articles of Organization:

ARTICLE I

Name

The name of the limited liability company shall be:

THE THREE BROTHERS, L.L.C.

The principal place of business of the Company in Florida shall be located at

13740 NW 19th Avenue, Miami, Florida 33054.

ARTICLE II

Duration

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The term for which this Company shall exist, shall be perpetual.

ARTICLE III

Purposes and Powers

The general purposes for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida, and shall have all the powers granted to a limited liability company under the laws of the State of Florida. Without limiting the generality of the foregoing, the Company shall specifically be empowered to:

1. Purchase, receive, lease or otherwise acquire, own, improve, use and otherwise deal with real or personal property or any legal or equitable property.

- 6. Be promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other entity.
- 7. Make donation to the public welfare, or for charitable, scientific or educational purpose.

ARTICLE IV

Registered Office and Agent

The name and street address of the registered agent of the company in the State of Florida is Lafontaine Mertilus, 13740 NW 19th Avenue, Miami, Florida 33054.

ARTICLE V

Capital Contribution

The members of the Company shall contribute to the initial capital of the Company the amount of \$15,000.00.

ARTICLE VI

Additional Capital Contributions

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

ARTICLE VII

Admission of New Members

No additional members shall be admitted to the Company except with the unanimous consent of all its members and upon such terms and conditions as be

determined by all the members.
