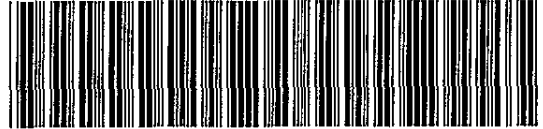

**ARTICLES OF ORGANIZATION
OF
I.B. MATERIALS, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is I.B. MATERIALS, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on October 20, 2104.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

**ARTICLE VII
PURPOSE**
