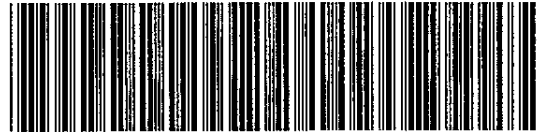



ARTICLE III - DURATION




ARTICLE V - MANAGEMENT
