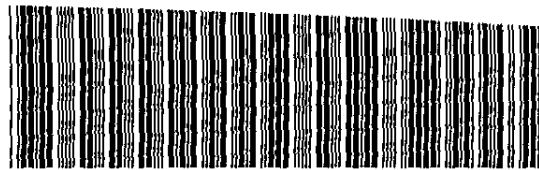

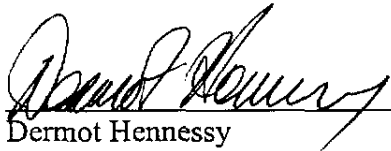
1. **Name.** The name of the limited liability company is Seafarer Resort, LLC.

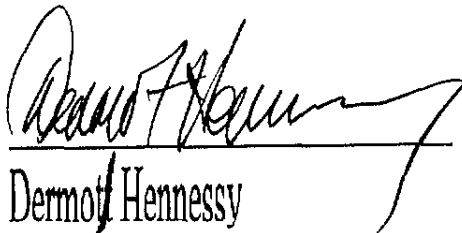
