
Biosearch, L.L.C., a limited liability company organized under the laws of the State of Florida (the "Company"), having taken action to dissolve under the provisions of Section 608.441, Florida Statutes, hereby submits these Articles of Dissolution for filing with the Florida Department of State.

1. The name of the Company is Biosearch, L.L.C.
2. The effective date of the Company's dissolution is upon the filing of these articles with the Florida Department of State.
3. Pursuant to Section 608.441(1)(c), Florida Statutes, the Company is dissolved by written consent of the Voting Members owning two-thirds of the Units and two-thirds of the Managers pursuant to the Operating Agreement of the Company. Dissolution was authorized by written consent on February 28, 2005.
4. Adequate provision has been made for the debts, obligations and liabilities of the Company pursuant to Section 608.4421, Florida Statutes.
5. All remaining property and assets have been distributed among the Company's members in accordance with their respective rights and interests.
6. There are no suits pending against the Company in any court.
