ARTICLES OF ORGANIZATION OF MURPHY BROKERS AND PROFESSIONAL SERVICES, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The name of the limited liability company shall be Murphy Brokers and Professional Services, LLC, and its mailing address and principal office and shall be located at 502 Parkwood Drive, Panama City, FL 32405, County of Bay, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

- 5. The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.
