



ARTICLES OF ORGANIZATION
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do hereby set forth the following:

ARTICLE I – NAME OF CORPORATION

The name of the Limited Liability Company (the "Company") is Great Training, LLC.

ARTICLE II – PERIOD OF DURATION

The term of existence of the Company shall commence with the execution of these Articles of Organization with the Secretary of State of the State of Florida, and shall continue until December 31, 2044, unless sooner dissolved pursuant to the Regulations, the Articles or by operation of law.

ARTICLE VI – CONTINUITY OF BUSINESS


