The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the limited liability company shall be **COASTLINE DEVELOPMENT GROUP, LLC**, ("Company").

### ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 9442 Lotus Court, Boynton Beach, Florida 33436 and the mailing address shall be Post Office Box 4393, Boynton Beach, Florida 33424.

### ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

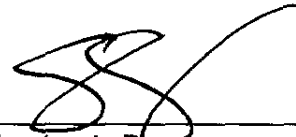
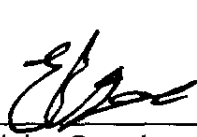

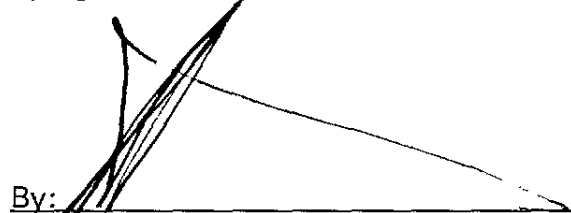
