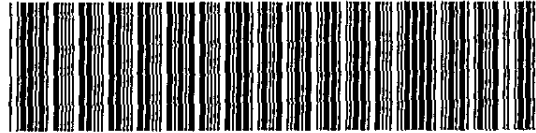

This Agreement made this 8<sup>th</sup> day of February, 2005, by and between A Milestone, LLC, a Florida limited liability company, further identified by Fl. Document No. L04000087340 filed 12/3/04, ("Merging Milestone") and A Milestone, LLC, a Florida limited liability company, further identified by Fl. Document No. L04000088062 ("Surviving Milestone").

**Recitals**

1. Merging Milestone is a limited liability company duly organized under the laws of the state of Florida.

2. Surviving Milestone is a limited liability company duly organized under the laws of the state of Florida.

3. 



f. The effective date of the merger shall be upon filing with the Florida Secretary of State.




