ARTICLES OF ORGANIZATION FOR THE LIMITED LIABILITY COMPANY OF GOLF STRATEGIES ACQUISITIONS, L.L.C.

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida limited liability company (this "Company") pursuant to the Act and hereby set forth the following Articles S OLDEC THE ST. of Organization (these "Articles"):
