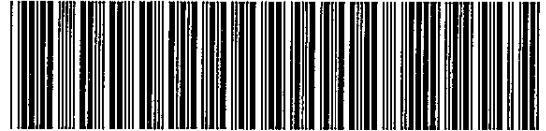

**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **BILLING RESOURCES, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

4. Place of Principal Office. The mailing address for the Company and the street address of the Company's principal office is 12479 Telecom Drive, Tampa, Florida 33637.


