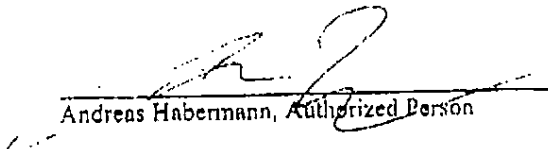

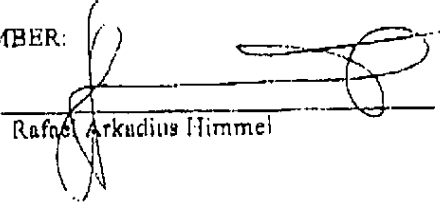
RESOLVED: That the following plan of liquidation of the Company be and is hereby adopted:
