3. The date the dissolution was approved on 10/1/05.



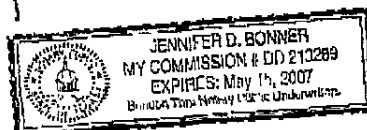
