ARTICLES OF ORGANIZATION

OF

PTJ PARTNERS, L.L.C.

ARTICLE I--NAME

The name of this limited liability company is PTJ PARTNERS, L.L.C.

ARTICLE II--PURPOSE

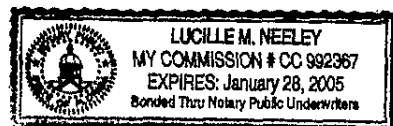
