ARTICLES OF ORGANIZATION OF NORTHSHORE 302, LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be NORTHSHORE 302, LLC.

ARTICLE II ADDRESS

ARTICLE III PURPOSE

ARTICLE VIII REGISTERED AGENT AND OFFICE

The Company designates 1819 S. Ocean Drive, Jacksonville Heach, Florida 32250, as the street address of the initial registered office of the Company and names Mark A. Werner, as the Company's initial registered agent at that address to accept service of process within this State.

ARTICLE IX CONTINUATION OF BUSINESS

Unless dissolved in accordance with the Company's Operating Agreement, the remaining Members shall continue the business of the Company, which shall not be dissolved, upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member.
