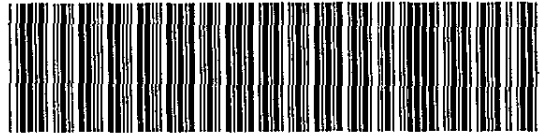



ARTICLES OF ORGANIZATION




