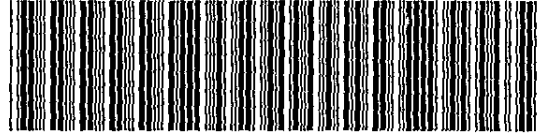

ARTICLES OF ORGANIZATION

OF

VINEYARD DIRECT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act ("Act"), chapter 608, Fla. Stat. (2003), hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I (NAME OF COMPANY)


