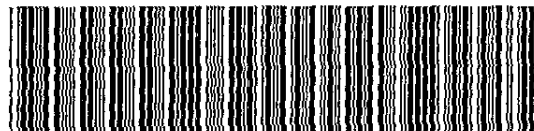

The Company shall be a member-managed Company.


ARTICLE V - PURPOSE


