The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "Frascati, LLC".

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 25 West Cedar Street, Suite 313, Pensacola, Florida 32502.

ARTICLE III - Duration:
