ARTICLES OF ORGANIZATION

The undersigned, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization

ARTICLE I. NAME

The name of the limited liability company is, Investors' Preference Group, LLC (herein the "Company").

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Regulations of the Company.

ARTICLE VIII, MANAGEMENT

Each Manager will retain such position until his or her resignation or until he or she is removed and replaced by the Members of the Company as provided in the Regulations of the Company. The Managers will have the obligations and responsibilities described in the Regulations of the Company. ARTICLE IX. REGULATIONS

The power to adopt, alter, amend, or repeal the Regulations of the Company will be vested in the members of the Company.
