ARTICLES OF ORGANIZATION OF T3 INVESTMENTS, LLC

The undersigned, acting as organizer of T3 Investments, LLC, under the Florida Limited Liability Company Act ("the Act"), adopts the following Articles of Organization for said limited liability company:
