**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 608.445 of the Florida Limited Liability Company Act, these Articles of Dissolution provide that:

ARTICLE I - NAME

The name of the limited liability company is VDH, LLC (the "Company").

ARTICLE II - DATE DISSOLUTION AUTHORIZED
