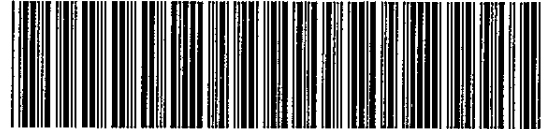



ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **BANYAN TITLE SERVICES, L.L.C.**



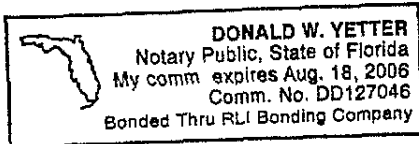


