**ARTICLES OF ORGANIZATION  
OF

Pursuant to the Florida Limited Liability Company Act, Florida Statutes Sections 608.401 to 608.705, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the limited liability company organized hereby:

**ARTICLE I  
NAME**


