Articles of Organization

1. Name. The name of this limited liability company is **ESITE Holdings, LLC** (the "Company"), and it shall do business as **Florida Limited Liability Company** under Chapter 608, Florida Statutes.

2. Duration. The Company shall exist from the date of filing, unless otherwise provided by the Florida Statutes or the Company's articles shall be terminated.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company located and transacted within Florida.

4. Place of Business. The mailing address and street address of the Company's principal office is 593 Lakewood Drive, Ft. Myers, Florida 33908.

4.5 Registered Agent and Office. To name and address of registered agent for the Company is **LLC Express, Inc.** The stated address of the registered agent of the Company is 150 Royal Plaza Square, Boca Raton, Florida 33487.

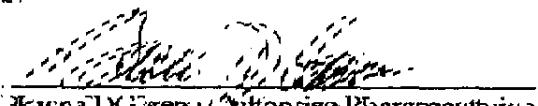
4.5 Management of the Company. The Company shall be managed by a sole manager or managers and is intended as a manager-managed company.

5. Operating Agreement. No member shall have the power to adopt, amend or repeal the operating agreement for the Company, containing provisions for the regulation and management of the affairs of the Company.

6. Votes. The Company shall have the right to issue membership units with voting, non-voting membership units with voting rights.

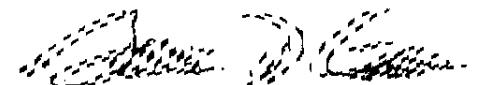
7. Confidentiality. The members' interest in the Company may be evidenced by certificates.
