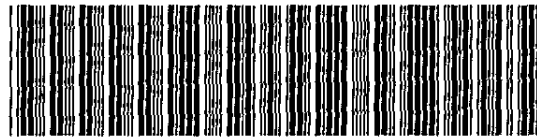

ARTICLES OF ORGANIZATION
OF
LONCLEAF FLORIDA, LLC

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is **LONCLEAF FLORIDA, LLC.**

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 4422 North Church Avenue, Suite J, Tampa, Florida 33614.

Article III. Registered Office and Agent. The post office address of the initial registered office of the Limited Liability Company is located within the City of Clearwater at 2201 N.E. Article VI. Admission of Members. The initial members of this Company shall be set forth in the operating agreement adopted by the members. The admission of additional members shall be as stated in the operating agreement.

Article VII. Written Operating Agreement. Any operating agreement entered into by the members of the Limited Liability Company, and any amendments or restatements thereof, shall be in writing. No oral agreement among any of the members or managers of the Limited Liability Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Limited Liability Company, as amended and in existence from time to time.

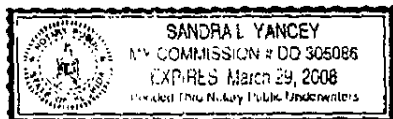
