**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

FIRST: The name of the limited liability company filing these Amended and Restated Articles of Organization is EHRlich AND SALLAPUDI, D.D.S., LLC (the "Company").

The Articles of Organization of the Company were filed with the Corporation Division of the Florida Department of State on December 13, 2004 under Document No. L04000090106.

SECOND: These Amended and Restated Articles of Organization were unanimously approved by the sole Member. The votes cast were sufficient for approval under the Company's Articles of Organization and Operating Agreement.

THIRD: The undersigned, being the sole Member of the Company, pursuant to the provisions of Section 605.0202 of the Florida Statutes, for the purpose of converting Ehrlich and Sallapudi, D.D.S., LLC, a Limited Liability Company, into a Professional Limited Liability Company governed by Chapter 621 of the Florida Statutes, does hereby adopt the following Amended and Restated Articles of Organization to supersede and take the place of the Company's heretofore existing Articles of Organization and any and all amendments thereto:

ARTICLE I - NAME

The name of the Company is SALLAPUDI ORTHODONTICS, PLLC.

ARTICLE II - DURATION

The duration of the Company is perpetual.
