

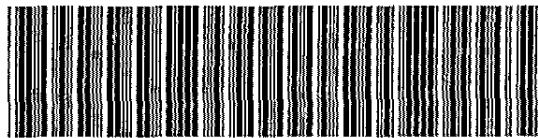



The mailing address and street address of the principal office of the Company is 2935 Forest Circle, Jacksonville, Florida 32223.



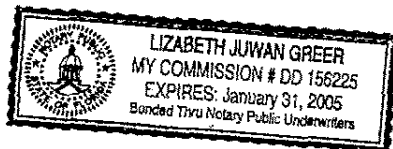


