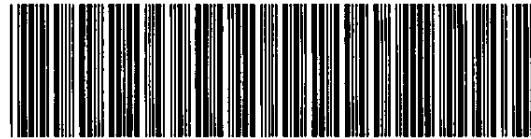

There were no assets of the company remaining after winding up. No debt of the company remains unpaid. The effective date of the Dissolution shall be the date of filing of these Articles.


ARTICLE IV - OCCURRENCE RESULTING IN DISSOLUTION


STATEMENT OF INTENT NOT TO REVOKE DISSOLUTION
