Article I. Name

The name of this Florida limited liability company is Eastern Coastal Development, L.L.C.

Article II. Duration

The duration of this limited liability company shall be perpetual unless the limited liability company dissolves in accordance with the provisions of the company's regulations, in accordance with these Articles of Organization or in accordance with the laws of the state of Florida.

Article V. Percentage Interest in Membership

The profits and losses of the company shall be allocated to the members in accordance with and in proportion to each member's percentage of interest (which shall be equal to the number of units owned by a member divided by the total number of units owned by all of the members), unless otherwise provided in the Regulations of the Company.

Article VI. Dissolution


Article VIII. Purpose of the Company


