## **ARTICLES OF ORGANIZATION**

### **WESTWAY, L.L.C.**

The undersigned person, acting as the organizer of WESTWAY, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

#### **ARTICLE I - NAME**
