

ARTICLES OF ORGANIZATION OF DONALD LEE INVESTMENTS, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act., F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization

ARTICLE 1 - NAME

The name of the Limited Liability company shall be DONALD LEE INVESTMENTS, L.L.C.

ARTICLE II - ADDRESS
