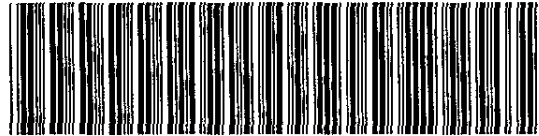

A LIMITED LIABILITY COMPANY


