The name of the limited liability company is **TRG OASIS, LLC** (the "Company").

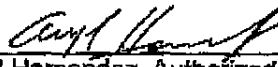
ARTICLE II - Address

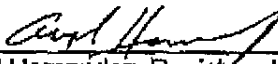
