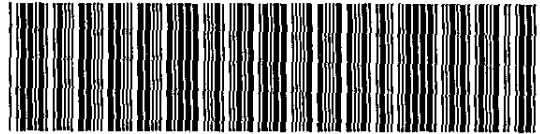

NAME AND PRINCIPAL OFFICE

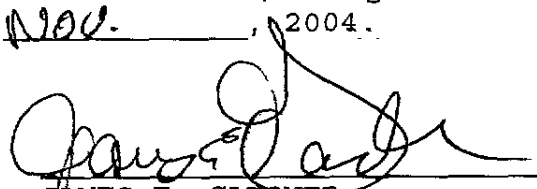

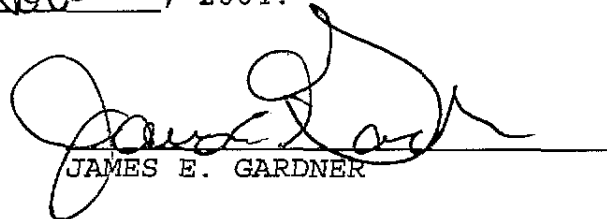
